## HCMC to establish Cai Mep Ha Free Trade Zone

HCMC has officially launched plans for the **Cai Mep Ha Free Trade Zone (FTZ)**, covering nearly **3,800 hectares** and directly linked to the Cai Mep - Thi Vai deep-water port complex - one of the few gateways in the region capable of receiving mother vessels sailing **directly to the U.S. and Europe.**

## Vietnamese exports leverage UK tariff perks



CPTPP accession boosts Vietnam's exports to the UK. Lower tariffs sharpen product competitiveness and catalyze logistics and supply chain growth.



CPTPP is expected to serve as a key catalyst, helping Vietnamese businesses expand markets, optimize costs, and strengthen trade connections with the UK in the coming period.

## Vietnam hikes US agri-imports on 0% reciprocal tax

### United States

The U.S. cut tariffs on Vietnamese goods from **46% to 20%**, while Vietnam keeps **0% tariffs on U.S. imports**. In 2025, Vietnam-US produce trade flourished: imports from the US spiked **67%**, alongside steady export growth.

**First-ever** Vietnamese chips have entered Japan, marking a **historic leap** for the nation. This milestone shifts Vietnam from **manual assembly** to **high-tech semiconductor innovation**.

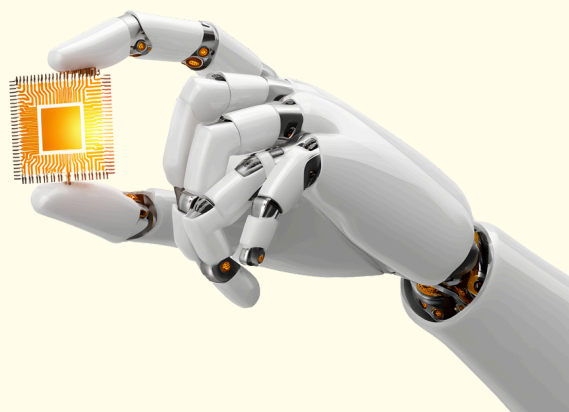

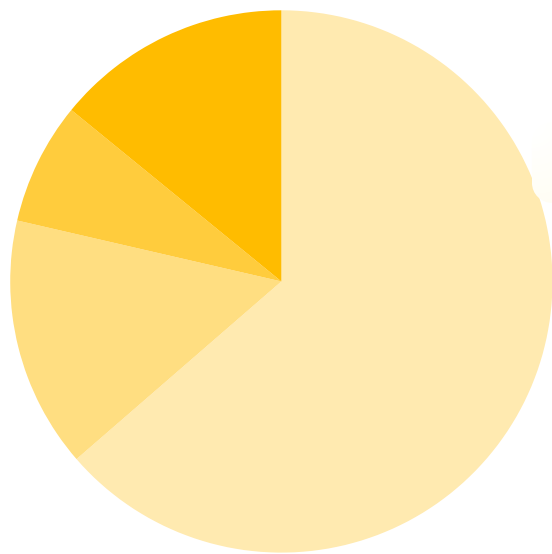

## Vietnam becomes Singapore's 10th largest trade partner

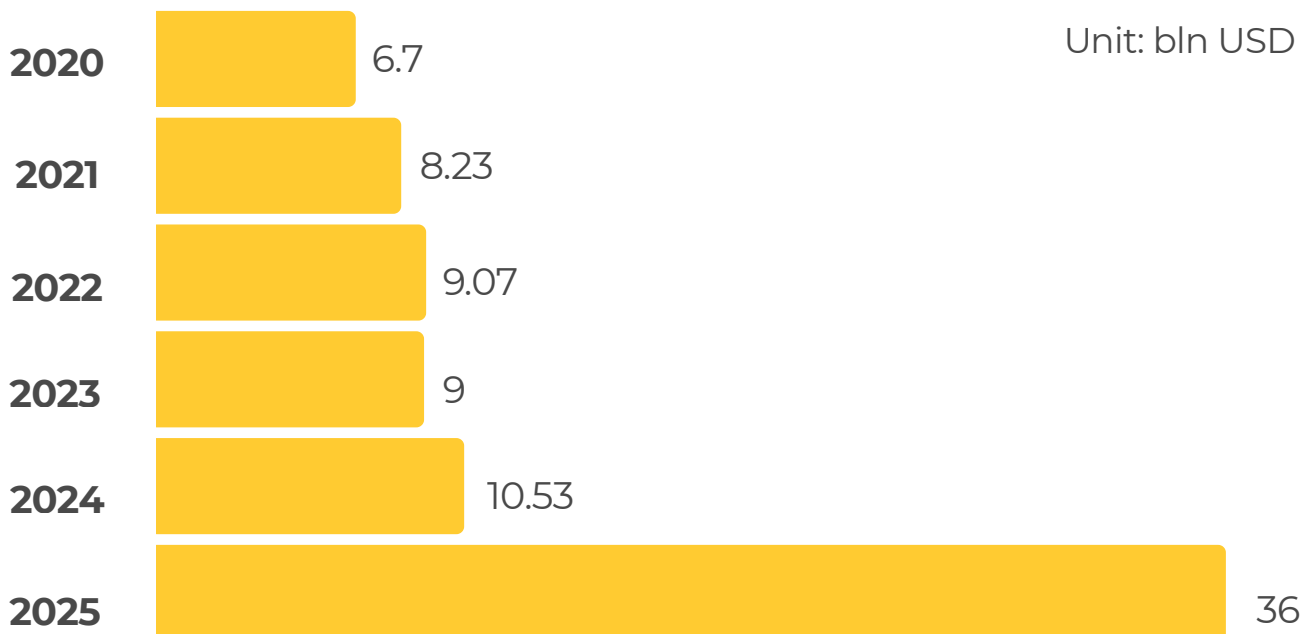
Vietnam ranks as Singapore's **10th-largest trading partner**, posting a **SGD 4.88 billion** trade surplus (excluding re-exports), fueled by a **105.5%** jump in electrical machinery and equipment exports.

Up **5.7%** compared to 2024

Export output reached **766,585 tons**, an increase of **5.7%** compared to 2024. These numbers solidify Vietnam's reputation as the world's processing hub for the cashew nut.

Notably, China surpassed the U.S. to become the largest importer of Vietnamese cashews, with an export value **exceeding \$1.1 billion**.
